The Redemption Center agrees to commingle the brands listed on the attached Schedules A through E according to the option selected and will certify the accuracy of the bag and case counts.

This Application will automatically terminate upon the termination of the Redemption Center License, unless and until the License is reinstated or renewed by the Department of Environmental and Protection.

SORTING OPTIONS

The Maine Bottle Bill provides that qualifying containers shall be commingled by product group, material and size, without regard to distributor or brand. When adopting the Bottle Bill, the Legislature expressed its intent to enhance the environment, reduce litter and minimize the cost of solid waste disposal.
